Shink panel were stained by using Knorr meat sauce. After staining, shink panel were dried 200°C for 1 hour in the oven. After they were kept in room temperature for 24 hours. 5g of product was absorbed homogenously on a moisturized the green side of the sponge with distilled water. The green side of the sponge was attach on the rubbing machine and the rubbing process was performed with 1 Kg weight 20 cycle

per minute on a greased shink panel.
